



**Important Notes for Home Education Members not enrolling in SFA:**

1. BNCHE operates on a 51% rule. What this means is that parents are required to personally teach their children at least 51% of the time. This still leaves the opportunity for tutoring and a part-time co-op. Exceptions will be made on an individual basis for dual-enrollment and other special conditions. Students receiving more than 51% of their instruction at Sancta Familia Academy shall be ENROLLED in the Academy and not in a home education program with Brevard County.
2. BNCHE and SFA reserve the right not to approve any Application for Membership and the right to revoke membership if any information has been misrepresented or if the terms of agreement for membership have been defaulted upon. If your Application for Membership cannot be approved, BNCHE will refund your monies and send you a letter of explanation.
3. BNCHE requires at least one Parent to attend both the January General Meeting and the Annual Business Meeting to remain a Member In Good Standing.

*The Symbolum Apostolorum* was developed between the second and ninth centuries. It is the most popular creed used in worship by Western Christians. Its central doctrines are those of the Trinity and God the Creator. Each of the doctrines found in the creed can be traced to statements current in the apostolic period. The earliest written version of the creed is perhaps the *Interrogatory Creed of Hippolytus* (ca. A.D. 215). The current form is first found in the writings of *Caesarius of Arles* (d 542).

Further, we believe the Holy Bible as contained in the Old and New Testaments, and the Church as found in papal teachings, has given the parents the final authority and responsibility for the training and education of their children.
